Re: SB 280 - Labor and Employment - Payment of Wages - Minimum Wage and Enforcement LETTER IN OPPOSITION Heard on February 21, 2019 at 1:00 p.m.

Dear Chairman Kelley:

The Commissioners of St. Mary's County oppose SB 280 - Labor and Employment - Payment of Wages - Minimum Wage and Enforcement which was heard in the Finance Committee on February 21, 2019.

St. Mary's County currently uses grade and step scales for hourly employees, merit employees sworn law enforcement officers and correctional officers. The scales provide a variance between grades and a variance between steps. For example, on the merit scale a 2.5% variance exists between steps. If the minimum wage would increase from \$11.82 (grade 1, step 1 on the merit scale) to \$15.00, or by 27%, and the County kept its same scale structure and increased the minimum which is currently \$11.82 to \$15, wages would increase approximately \$12.6 million. This is because in order to keep our scale structure, the 27% increase would not only affect the lowest grade, but it would affect all grades thereafter in order to avoid salary compression and to maintain the variances between grades and steps. In addition, benefits such as FICA, workers comp, and pension will calculate based on wages, further increasing costs by \$3.5 million for a total increase of approximately \$16 million to the County. These costs will be passed on to citizens and some examples of cost increases for citizens would be higher summer camp costs and child care costs. Child Care costs would increase by \$350,000.00 and summer camp costs would increase by \$50,000.00 in St. Mary's County.

We do not believe this bill would benefit the citizens of St. Mary's County. We look forward to working with you on this and other initiatives throughout the session.
