- Child Advocacy Ms. Russell shared statistics from the Child Advocacy Center for the month of April there were 8 sexual assault cases and 6 physical assault cases referred. During the month of May there were 7 sexual assault cases and 8 physical assault cases referred.
- Lethality Assessment Program Walden Sierra has been referring cases for the Lethality Assessment Program.

- Education and Social Media Ms. Croyle would like to write an article for the *Southern Maryland Woman*.
- Fatality Review No fatalities to report. Ms. Russell stated due to the number of new members, the Fatality Review Team notebook will be prepared and distributed to all members. Prior to reviews, a confidentiality statement will be required. A fatality is not required for a review; serious injuries are included under the review process. The Council will conduct a fatality review in October.

- Victim Follow-Through Ms. Joyce requested information from the providers on the amount of victim follow through and would like agencies to pull information together and how victims are assisted long-term. Ms. Joyce will work on a flow chart to distribute to members. Judge Abrams expressed concern with follow-through with the victims utilizing Walden Sierra's available services.
