2023 ANNUAL REPORT**

Introduction

The St. Mary’s County Animal Control Advisory Board (ACAB) was adopted as a Board on January 8, 2019, effective January 22, 2019.

The Board shall advise the Commissioners of St. Mary’s County (CSMC) on all matters relating to the development and management of the Animal Shelter and the St. Mary’s County Animal Control Ordinance. The purpose of the Board is to assist in animal shelter site selection, building design, emergency plans, policies and procedures. The Board will review and discuss budgets and operational plans of the animal shelter and advise on animal shelter staffing as well as spay and neuter policies. The Board will assist in the development of a 5 Year Strategic Plan for the Animal Shelter, serve as a liaison to the community to increase support and awareness of the Animal Shelter, and review and make recommendations on the Animal Control Ordinance.

The membership of the ACAB shall be seven (7) citizen members; the Animal Control Supervisor from St. Mary’s County Government or other member of Emergency Services designated by the Director (ex officio) and a representative from the St. Mary’s County Health Department (ex-officio).

The ACAB meets 6 times a year, on the first Wednesday on odd months. St. Mary’s County ACAB met 5 times this year. The July meeting was cancelled due to a holiday. The major focus of the meetings during 2023 was the staffing, county animal ordinances, and hiring of a part time Veterinarian for the **Animal Adoption and Resource Center {AARC}**. Meetings this year also provided presentations on various topics from staff including how to volunteer at the AARC and Animal Adoption.

Elections

Election for Chair, Vice-Chair and Secretary positions were held in March 2023. Rita Weaver was elected Chairperson, Steve Tuttle was elected Vice-Chair, and Dr. David Langford was elected Secretary.

ACAB Subcommittees

ACAB Subcommittees – the Public Education and Outreach met one time in December. The focus was to determine ways to support the AARC. The meeting included members of ACAB, AARC Volunteers, and community animal organizations.

The ACAB is dedicated to serving the citizens and domestic animals of our community by advising the Commissioners of St. Mary's County on Animal Shelter and Animal Control Ordinance matters.
