#### **NEW BUSINESS**

 Resolution Establishing Economic Development Council to replace the Economic Development Commission

Memorandum received from County Attorney that the St. Mary's County Department of Economic Development submitted for review by County Attorney's office revision to the previous draft Resolution to establish the Economic Development Council to replace the Economic Development Commission. Mr. Roberts made the motion that we advise Mr. Norris that pursuant to his request of Feb. 21, 2003 regarding the Resolution Establishing Economic Development Council to replace the Economic Development Commission, it is the Ethics Commission's position that members of the Economic Development Council be required to file Financial Disclosure Statements. Motion seconded by Ms. Siemasko and motion carried.

## Resolution to Establish Adequate Public Facilities Taskforce and Request for Exemption from Ethics Ordinance Relating to Conflicts of Interest

Memorandum from Assistant County Attorney enclosing Draft Resolution for the purpose of establishing the St. Mary's County Adequate Public Facilities Taskforce and requesting the Ethics Commission grant an exemption from the applicable requirements of the Ethics Ordinance concerning conflicts of interest for members of the Taskforce. Ms. Springrose was invited to attend the meeting to further discuss the memo.

Dr. Neal offered for the Ethics Commission to do an education presentation to this group at its first meeting. She feels there is a misconception about when you should recuse yourself. The Ethics Ordinance specifically precludes our granting an exemption to the Adequate Public Facilities Taskforce.

The motion was made by Mr. Roberts that the Ethics Commission respond in the negative because the Taskforce doesn't meet the Ethics Ordinance's three criteria for exemption 1) Constitute an unreasonable invasion of privacy; and 2) Significantly reduce the availability of qualified persons for public service and further; 3) Not be required to preserve the purpose of this Ordinance. The motion was seconded by Mr. Deaderick. Motion carried.

## Public Information Request from Elizabeth Reeves

Memo received from Ms. Springrose, regarding request for Financial Disclosure Statements for Ms. Shelby Guazzo from 1998 through 2002. Dr. Neal advised Ms. Springrose that we are only required to keep those on file for three years. We will be glad to provide those for the three years available.

## BOCC letter regarding vote on sewer and water for Kings Christian Academy in Callaway

Letter received from Board of County Commissioners advising us that the BOCC agenda for 3/24/03, includes an item for decision regarding a Comprehensive Water and Sewer Amendment request for the King's Academy property in the Callaway area of St. Mary's County following a previous public hearing. A response will be sent to the BOCC advising them that a decision has been rendered to dismiss the complaint and we see no conflict in any decision made by the BOCC.
