A discussion took place regarding sending a strong letter to those who are no longer serving pointing out that they are obligated to file for the period that they served and failure to do so may put at risk some actions taken by that commission/board when they were serving. A letter will be drafted and sent to

those four who are no longer serving and the regular cease and desist letter is ready for mailing today to the eight individuals who are still serving.
