# MORGAN STANLEY UPDATE – 1st QUARTER 2015 FINANCIAL REPORT

Jeff Seibel from Morgan Stanley provided a Performance Measurement Report for the period ending March 31, 2015. The Combined Account portfolio was up 1.62% for the quarter. Although the Domestic Equity portfolio was up 1.67% for the quarter, Putnum Spectrum struggled at -1.79% for the current quarter. The International Equity portfolio was up 2.78% for the quarter even though Wentworth Hauser (heavy in energy) struggled at -1.12%. Mr. Seibel still thinks that Wentworth Hauser will add value to the portfolio in the future. The Fixed Income portfolio was up 0.37% for the quarter although the Loomis Sayles Fixed Income fund struggled at -1.03. The Real Estate portfolio was up 3.97% for the quarter. Overall, the Hedge Funds & Private Equity portfolio was up 2.14% for the quarter even though the Virtus Dynamic AlphaSector fund was down -2.46%. The beginning market value of the Plan was \$65,617,683 and the ending Market Value of the Plan was \$67,374,873.
