A. Maryland Agriculture Land Preservation Foundation (MALPF)

No update at this time.

#### B. Rural Legacy

The Maryland Department of Natural Resource's (DNR) office still has not announced their FY2020 awards. Patuxent Tidewater Land Trust (PTLT) - Ms. Marek updated the Board that PTLT is currently renegotiating the Buckler Easement that was rejected by DNR.

Southern Maryland Resource Conservation & Development (RC&D) - Ms. Greb announced that RC&D has currently settled on all easements submitted as part of last year's grant application. RC&D also attended a meeting in Calvert County that showcased the REPI efforts through St. Mary's County.

# C. Regional Agriculture Center (RAC)

Ms. Veith updated the Board that she continues to work with SMADC Staff and consultants to update the layout of the RAC.

## D. Relocation of North St. Mary's County Farmers Market

Ms. Veith informed the Board that this project is currently in the site plan stage.

## 6. NEW BUSINESS

A. CIP Requests - Ms. Ledman told the Board that all reoccurring CIP requests (land preservation programs) have been submitted to the County's Finance Department. Two new projects consisting of a California Farmers Market Building and an Urban Legacy Program were also submitted for consideration.

## B. Open Comment Period

Mr. Beale updated the Board that there will be market impact on the pulp wood industry due to the Western Maryland Paper Mill closing. Mr. Beale also told the Board of a push in the timber industry to revamp the permitting issue - this is not an issue in St. Mary's County.

Mr. Langley spoke of the additional 18-20% striped bass reduction and a 20% reduction in oyster harvesting (no oystering on Wednesdays).

Ms. Veith announced that Phil Langley was named Waterman of the Year at this year's Blessing of the Fleet.

Mr. Reeves is concerned about Board attendance. He would like the Board to consider reducing membership from 14 members to a smaller number to ensure that a quorum can be met each month.
