A. WITHDRAWN CEDAR COVE MARINA VAAP 23-0176; Variance from Section 71.8.3 to disturb the Expanded 100' Critical Area Buffer to construct a new home with a marina office, two covered porches and garage.

B. LOVEVILLE MINE EXPANSION CUAP 23-0047; The Applicant requests the modification of conditional use approval 15-131-050 and 21-131-0001 to expand mining operations by 12.2 acres, pursuant to Chapter 25 of the Comprehensive Zoning Ordinance, for use type 82, Extractive Industry within the Rural Preservation District (RPD).

C. DROVE COLLISION VAAP 23-0240; The Applicant requests a variance from Schedule 63.3.a to remove the 65' Type B Buffer Yard along MD Route 5 and Three Notch Trail and to remove the 30' Type C Buffer Yards adjacent to the residential use properties. Additionally, the Applicant is requesting a variance from Schedule 64.3.1 to reduce the required parking of 51 spaces (3 ADA spaces included) to 20 spaces (1 ADA space included).

D. PAX RIVER VILLAGE VAAP 23-0152; The Applicant requests a variance from Schedule 63.3.a to remove the 65' Type B Buffer Yard along MD Route 235, Shangri-La Drive, Great Mills Road and FDR Boulevard and a variance from Schedule 32.1 to reduce the required 20 % landscaping in the LCI District to 15%.
