## Premise change

Requesting temporary extension of premises and extra serving counter for Bats and Boos event on 10/29/22 from 5:00 pm to 9:00 pm.

Richard Copsey and Rachael Copsey appeared before the Board and were sworn in. Mrs. Copsey explained that they wanted to add a small event on October 29, 2022. This event will have four security personnel with temporary fencing for safety measures. The Copsey's also wanted to secure a rain date, for an already approved event on December 3, 2022, of December 4, 2022. Vice-Chair Watts moved to approve the rain date addition and the temporary extension of premise and extra serving counter for the event on October 29, 2022. Motion was seconded by Member Hill. Yulliana Del Carmen Marcano appeared before the Board and was sworn in. Ms. Marcano had Carlos Bravo translate the Board's questions for her. Mr. Bravo was sworn in. Ms. Marcano stated that the violation did occur. Mr. Bravo explained that Ms. Marcano has taken TIPS on-line training, but Maryland doesn't recognize on-line training without the proper proctored testing. Vice-Chair Watts made a motion for a \$150.00 fine. Receiving no second, motion failed. Member Hill made a motion for a fine of 250.00. Motion was seconded by Chairman Willenborg. Motion carried. Vote: 2 to1; Vice-Chair Watts against.

## Licensee(s): Carlos Bravo

Sale of alcoholic beverages to a person under the age of twenty-one (21) in violation of §6-304 of the Alcoholic Beverages Article of the Annotated Code of Maryland and §5.04(j) of the Rules and Regulations of the Alcohol Beverage Board of St. Mary's County.

Carlos Bravo being already sworn in, appeared before the Board. Mr. Bravo stated that the violation did occur. Mr. Bravo explained that he has his employee's alcohol awareness trained by TIPS and that he will have Ms. Marcano certified as well. Vice-Chair Watts made a motion for a \$1000.00 fine, \$500.00 held in abeyance for 3 years as well as RAST training. Motion was seconded by Member Hill. Motion carried.

## Gridiron Grill - Employee: Ashley Marie O'Haran

The above individual, Ashley Marie O'Haran, was an employee of a license holder and sold or provided alcoholic beverages to an individual under the age of twenty-one years in violation of §6-304 of the Alcoholic Beverages Article of the Annotated Code of Maryland and §5.04(j) of the Rules and Regulations of the Alcohol Beverage Board of St. Mary's County.

Ashley M. O'Haran appeared before the Board and was sworn in. Ms. O'Haran stated that the violation did occur. Ms. O'Haran had no explanation why she asked for an ID but didn't wait for it to be shown. Vice-Chair Watts made a motion for a fine of 250.00. Motion was seconded by Member Hill. Motion carried.
