NEW BUSINESS

Applications

The Brass Tap Craft Beer Bar & Kitchen - Application for Josephine Snavely, Michael Snavely and Candace Snavely to purchase a Class D-BWL license and t/a The Brass Tap Craft Beer Bar and Kitchen (MD Enterprise, LLC aka TJ Enterprise, LLC), 44940 St. Andrews Church Rd., Ste A-C, California, MD 20619. And permission for outdoor seating and refillable/non-refillable permit.

Josephine Snavely, Michael Snavely and Candace Snavely appeared before the Board and were sworn in. Mr. Snavely explained to the Board that The Brass Tap is a franchise that he and his wife and daughter will be operating. They are asking for a 90-day conditional approval to start the renovation process. Member Kohl made a conditional 90-day approval pending the Health Department, Fire Marshal, Traders License and Use and Occupancy permit. Motion was seconded by Member Shin. Motion carried.

The above individual, Monica Leann Adkins, was an employee of a license holder and sold or provided alcoholic beverages to an individual under the age of twenty-one years in violation of §6-304 of the Alcoholic Beverages Article of the Annotated Code of Maryland and §5.04(j) of the Rules and Regulations of the Alcohol Beverage Board of St. Mary's County.

Monica Adkins appeared before the Board and was sworn in. Mrs. Adkins admitted the violation did occur. Mrs. Adkins stated that she thought she had served this customer before and had checked his ID then, so she didn't ID him this time. Member Shin made a motion for a \$150.00 fine to be paid in 10 days. Motion was seconded by Vice-Chair Watts. Motion carried 4:1; Chairman Willenborg against.

Licensee - Brian Louis Adkins

Sale of alcoholic beverages to a person under the age of twenty-one (21) in violation of §6-304 of the Alcoholic Beverages Article of the Annotated Code of Maryland and §5.04(j) of the Rules and Regulations of the Alcohol Beverage Board of St. Mary's County.

Brian Adkins appeared before the Board and was sworn in. Mr. Adkins admitted that the violation did occur. Mr. Adkins stated that he plans to have all his clerks and bar staff do 100% ID check and attend Alcohol Awareness training and RAST. Vice-Chair Watts made a motion for a \$1000.00, \$250.00 held in abeyance and RAST within 90 days. Receiving no second, motion failed. Member Shin made a motion for a \$1000.00, \$500.00 held in abeyance to be paid in 10 days and RAST within 90 days. Motion was seconded by Vice-Chair Watts. Motion carried 4:1; Chairman Willenborg against.

St. Mary's Landing Steak House Employee - Kaylah Laveatta Brown

The above individual, Kaylah Laveatta Brown, was an employee of a license holder and sold or provided alcoholic beverages to an individual under the age of twenty-one years in violation of §6-304 of the Alcoholic Beverages Article of the Annotated Code of Maryland and §5.04(j) of the Rules and Regulations of the Alcohol Beverage Board of St. Mary's County.

Kaylah Brown appeared before the Board and was sworn in. Ms. Brown admitted that the violation did occur. Ms. Brown stated that she had not been given any training on the sale

of alcohol beverages during her employment at St Mary's Landing Steak House. Vice-Chair Watts made a motion for a fine of \$50.00 to be paid in 10 days. Motion was seconded by Member Kohl. Motion carried.

Licensee - Kim Poh Seow

Sale of alcoholic beverages to a person under the age of twenty-one (21) in violation of §6-304 of the Alcoholic Beverages Article of the Annotated Code of Maryland and §5.04(j) of the Rules and Regulations of the Alcohol Beverage Board of St. Mary's County.

Kim Seow appeared before the Board and was sworn in. Mr. Seow admitted that the violation did occur. Mr. Seow stated his manager oversaw the training of new employees. Mr. Seow stated that he has since gone out of business. Vice-Chair Watts made a motion for a fine of \$500.00 to be paid in 10 days. Motion was seconded by Member Shin. Motion carried.
