#### Violations

Judith Taylor appeared before the Board and was sworn in. Ms. Taylor admitted that the violation did occur. Vice-Chair Watts made a motion for a \$150.00 fine and was seconded by Member Anas. The vote was 4:1 Chairman Willenborg against. Motion carried.

Kenneth Held appeared before the Board and was sworn in. Mr. Held admitted that the violation did occur. Vice-Chair Watts made a motion for a \$1000.00 fine, 3-day suspension and RAST training and was seconded by Member Anas. The vote failed. Vice-Chair Watts made a second motion for a \$1000.00 fine and RAST training and was seconded by Member Anas Motion carried.
