Sarah is the Education and Program Coordinator: She spoke of the new Second Saturdays programs that are more
drop-in, flexible and high value with low cost, using the environment. For example, the one yesterday that was "Shore
Combing" at Piney Point Lighthouse & Museum looking at the river environment. The next one will have an autumn
theme; young people will look at sensory things and older ones will be introduced to tracking and shelter building

- Zach is the Fundraising Coordinator: He spoke of his goal to modernize the Friends organization with new technology
 to track membership and program attendance, expanding the member base and ramp up donations and enhance
 fundraising amounts
- F. Department of Recreation & Parks Update
 - · Arthur is staying on in his position rather than having the county appoint an interim Department Head
 - · Three new playgrounds are being built
 - The Snow Hill Park plan was generally well-received but concerns about accessibility were raised, so it is going back for final approval
 - The Royal Farms development is adjacent to the Passive Park and Community Garden in Lexington Park and concerns have been raised about how this development will affect public lands. Those concerns are being addressed to ensure that the park will not be affected
 - The Department is now nationally accredited the 199th in the country and 6th in Maryland to be accredited
