- Brandy Tulley, Senior Center Operations Manager, Department of Aging & Human Services, provided information about the Senior Centers and the special programs offered by the centers. Home-Delivered Meals, Fitness classes, Congregate Meals, and senior center goals, were discussed.

## **COMMITTEE REPORTS:**

- Homeless Coalition Carolyn Guy
  - The Homeless Prevention Board met on February 16th. The Point in Time Survey ran on January 26th. The number of homeless families increased to 54. Forty-nine families are sheltered, most at Three Oaks, 11 families have children, with a total of 37 homeless children. All children are sheltered. Since July, 36 families have received long-term housing. The WARM program will not operate this year. Their funding has been given to Three Oaks to help provide housing to homeless families. ERAP round 2 is \$1.4 million provides financial assistance to families for overdue rent and utility or home energy costs. The libraries are now open on Sundays. The Leonardtown Library is offering a vaccine clinic on March 1st from 12p -5p. No registration is required.

  - Discussed proposed objectives for the committee.
- Senior Transportation Virginia Morris, Janet Perryman
  - Information was sent to members about a new bill regarding transportation. Members will try to attend the Transportation Advisory Committee's next meeting and are also planning to meet with staff from the Department of Transportation to get more information about transportation.
- Senior Legislation Gail Murdock, Rowena Bossio
  - Established a goal of providing information regarding current senior legislation. Also provided information on current bills and information about how to send letters of support.

  - Mr. Ridley attended the 2022 Military & Veteran Cultural Diversity Symposium and provided a brief synopsis
    to the members.
